

It tracks your bus journey and will tell you exactly when your bus is due to depart from your stop. This can be used anywhere via your mobile phone or pc so you can stay warm and dry as long as possible and less time at the bus stop.

Peter Hardy, Buckinghamshire's Cabinet Member for Planning and Transport, said: "As well as providing live information to passengers, nextBus also helps us monitor punctuality so we can work with bus companies to improve reliability, making catching the bus a smarter way to travel."

You can access nextBus in a number of ways:

- Our new look website www.nextbus.travel has been improved with an interactive map and easy to use bus stop and route number search facilities.
- To get live bus times via mobile internet go to www.nextbuses.mobi
- Via SMS text your busstop code (found on your bus stop flag or at www.nextbus.travel) to 84268 and receive a text back with the live times for the next few buses. Texts cost 25p plus your standard network charge

There will be a kiddies funfair operating in the precinct and a range of entertainment taking place from a stage in the centre of the village. WRG (Waste Recycling Group) have been awarded the new contract for Buckinghamshire County Council's ten household waste recycling centres, which will come into place from 1st April 2012. This contract will deliver an anticipated saving of between £2.1m and £3.2m* over seven years for Buckinghamshire taxpayers.

WRG will be working with the Council to deliver an improved service to residents which aims to reduce the amount of damaging and expensive waste sent to landfill and achieve an overall county-wide recycling target of 60 per cent by 2025.

Cabinet Member for Environment, Steven Adams, said: "Our recycling centres are very popular and divert a huge amount of waste away from landfill through recycling and reuse schemes. However the difficult financial climate we are in demands that we are achieving savings alongside better levels of performance for residents. I am very pleased that this new deal will achieve this."

The new contract will provide an improved customer experience; this will include enhanced signage, improved layouts of recycling containers and 'meet and greet' attendants who will help customers unload waste to ensure items are recycled. There are also changes proposed for the reuse scheme, details of which will be released shortly.

Steve added: "The present contractor, Aylesbury Secondary Metals (ASM), who we have worked with for over 12 years, has done a great job in helping us to drive up recycling rates and maintain standards of customer service. I would like to thank all the site staff and ASM for their hard work and commitment. We will be working with ASM and WRG to ensure there is a smooth transition of any potential TUPE staff."

The new contract will start from 1st April 2012 and run until 31st March 2019 with options to extend annually until 31st March 2022. The contract is anticipated to be worth up to £22 million** and will provide the Council with the flexibility to provide service levels and costs which are affordable both now, during these difficult financial times, as well as in the future.

Once the contract commences, the most immediate change will be the opening hours at the sites. The sites will open an hour later and have fixed summer and winter opening periods and times, as follows:

1st April - 30th September (summer opening hours): Sites will open from 9am - 6pm.

1st October - 31st March (winter opening hours): Sites will open from 9am - 5pm.

Revision of opening hours follows analysis of the traffic counter data gathered during the consultation phase of the project, which showed that the lowest customer usage time period was between 8am and 9am daily across the week. The recycling centres will continue to close on Christmas Day, Boxing Day and New Year's Day.

Gordon Fergus, Group Commercial Manager for WRG, said: "We are delighted to have been selected by Buckinghamshire County Council for their HWRC contract. We believe it demonstrates WRG's ability to deliver the high quality service that the public demands, but in a cost-effective way that is important in these difficult economic times.

"We're looking forward to working with the people of Buckinghamshire in helping them to increase recycling and reduce the amount of waste that is sent to landfill."

NATIONAL Adoption Week (31 October - 6 November) aims to raise awareness of the constant need for prospective adopters - and to provide information for anyone interested in finding out more.

Val Letheren, Buckinghamshire's Cabinet Member for Safeguarding, said: "Adopting a child is not a step to be taken lightly, it can be both challenging and rewarding, but many who have taken that step have found it an incredibly positive and enriching experience. To give a loving and stable home to a child in care is, arguably, the greatest gift one human being can give to another.

"Adoption week is a great opportunity to raise awareness to the need for more adoptive families - in reality, we always need more people to consider adoption, it's an ongoing recruitment drive. But I would urge anyone who may have considered adoption, or fostering, to find out more about it. We'll have experienced staff on hand to offer prospective fosterers and adopter support and advice."

Buckinghamshire County Council is particularly interested in people who are interested in adopting children of mixed heritage, older children, sibling groups and children with specific disabilities. Adopters do not have to be of the same ethnicity/culture as the child, but would need to be able to ensure their ethnic and cultural needs are promoted.

The adoption team is keen to answer any questions you may have about adoption and holds regular information sessions if you would like to find out more.

2012 - a time for Buckinghamshire to party, says County's Leader

2011 may have been a time of tough austerity for most Buckinghamshire residents but looking forward to 2012 there should be much to celebrate.

Buckinghamshire will be a host county for the main London Olympic 2012 Games at Dorney Lake in south Bucks and of course is the home of the Paralympics at Stoke Mandeville. Add to this the Queen's Diamond Jubilee and there are "three great reasons to celebrate", Buckinghamshire County Council Leader Martin Tett told his Cabinet on Monday (19 September).

He said: "I want to give local communities the opportunity to be really involved. There is so much to be proud of with opportunities to cheer on the Games events themselves, celebrate the cultural heritage of the participating countries, organise themed summer fetes and hold street parties to enjoy the Jubilee. In the past it can have been a real challenge organising local events with so much 'red tape' for things like road closures etc. I have asked the county officers to work with our district colleagues to make it really easy and affordable for everyone to celebrate."

The County Council's Localities teams will be working closely with communities to plan jubilee celebrations, which will provide lasting legacies for residents.

Martin Phillips, Cabinet Member for Community Engagement said: "I'm committed to making 2012 a year to remember for Buckinghamshire residents and visitors."

THE much-anticipated Parliamentary debate on the proposed HS2 rail scheme went ahead on Thursday 13 October and like so many rail related projects, it arrived late!

The cause: A lot of hot air on the line - a long and some might say, tedious, debate on the use of handheld devices in the House of Commons went on, and on and on.... At one point Wycombe MP Steve Baker pleaded the business be allowed to move lest his 'constituents flay me alive'.

Martin Tett, Leader of Buckinghamshire County Council and Chairman of 51m - the alliance of 18 local authorities committed to challenging the Government's case for HS2 watched the debate from the public gallery. Martin said: "It was definitely not Parliament at its best. To drag out a debate on 'Twitter' in preference to discussing the proposal to spend £32Billion on taxpayers money on a highly controversial project shows strange priorities."

When the HS2 Debate did commence, Andrea Leadsom, Conservative MP for South Northamptonshire, opened stating in opposing HS2 she was defending the taxpayers of the UK against the spending £32 billion on an unjustifiable and eye-wateringly expensive project.

She blasted the business case, saying it made ludicrous assumptions and would never cure the North-South divide, as claimed, indeed 73% of any jobs created would be in London. Heavily subsidised by taxpayers, 99% of people in the UK would use it only once a year, she said. Other alternative measures could, she stated, be delivered more cheaply and immediately, easing capacity problems now. "We may not land a man on Mars by 2026, but there will be technical advances made which will make HS2 outdated before it's built."

She concluded: "HS2 will be a white elephant. It's not visionary, it's not green and it's not economically sound."

Geoffrey Robinson, Labour MP for Coventry North West, told the chamber HS2 would be subsidised massively by the taxpayer, thinking behind it was the wrong way round - the line from London to Birmingham was not needed, and any new line should be built from the north to the south. He described HS1 as 'the biggest flop ever. Sold off at a whopping loss'. Furthermore, he said, in all likelihood, the northern sections would never get built because of the enormous expense.

Steve Baker, Conservative MP for High Wycombe also opposed the scheme wanting to know if the financial returns were as good as the Government claimed why wouldn't private businesses invest in the scheme?

At the conclusion of the debate Martin Tett commented "I am delighted that the overwhelming majority of speakers were firmly against the scheme, including now MPs from inner London such as Frank Dobson (MP for Holborn and St Pancras) and the north such as Fiona Bryce (MP for Congleton). What the debate did reveal is the fundamental weakness of the HS2 case - the business case is flawed; there is no evidence that HS2 will bridge the north-south divide or achieve any regeneration benefits. It will be an environmental disaster, not just here in the Chilterns AONB but right along the line. There are huge disbenefits to our existing rail network and to many towns and cities in the Midlands and the North which will have the economic life drawn from them as they are bypassed by HS2 and suffer slower, reduced train services.

"It makes no sense at all to squander £32 billion on HS2 when local authorities are having to reduce services, small businesses, the backbone of our economy, are going bust for want of a few thousand pounds and we have two and a half million people unemployed.

"It is clear that those supporting the scheme were still unable to give any clear evidence in support of their views.

"It's time for the Secretary of State for Transport to put this vanity project to rest, scrap the scheme, go back to the drawing board and look at better ways of investing £32 billion in this country."
